1. Moving on with the pandemic and adapting to the so called "new normal" became the common norm nowadays. Guided by the BSP's theme, "Sustaining Growth" focusing on "Building Scouting Positivity Amidst Pandemic", the BSP-Western Visayas Region proudly invites the field to the 1ST BSP WVR REGIONAL SCOUT CYBER JAMBOREE (RSCJ) scheduled on 07-13 MARCH 2021 to be hosted by ILOILO (CONFESOR) COUNCIL, WVR, BSP through Online modalities.
2. This Cyber Jamboree will be our main platform in lieu of the accustomed physical gatherings in compliance to the protocols of the IATF. Generally, this event will provide a perfect venue where scouts and scout leaders in the region can convene, have fun, learn new scouting skills, and many more cyber/virtual scouting adventures while celebrating the great spirit of scouting brotherhood and sisterhood.
3. **PURPOSE:** This Jamboree aims to:
 - a) Introduce the use of virtual/online mode-type of jamboree as part of our resiliency response to this pandemic crisis in conducting scouting programs.
 - b) Share, impart, and demonstrate different scouting skills, knowledge, and scouting updates to the participants.
 - c) Provide a venue where scouts and scout leaders can actively participate and involve themselves to the scouting programs and activities prepared.
 - d) Develop among scouts and scout leaders strong sense of scouting commitment and camaraderie amidst the current situation.
4. **PLATFORM:** Primarily, we will be utilizing the Zoom video conferencing application. However, due to the flexibility of the online modality, we might as well use other virtual applications such as FB live streaming, FB page and other online platforms applicable to certain scheduled programs and activities.
5. **PARTICIPANTS:** This Cyber Jamboree is expecting 4,000 participants to include Scouts (KID, KAB, Boy, Senior, Rover), Unit Leaders, Lay leaders, Scout Parents/Representatives, and Scout Volunteers who are duly registered to the Boy Scouts of the Philippines.
