2019 PHILIPPINE EDUCATIONAL PLACEMENT TEST REGISTRATION

To: **Chief Education Supervisors

1. The Bureau of Education Assessment-Education Assessment Division (BEA-EAD) and DepEd Division of Aklan, announcing the registration for the 2019 Philippine Educational Placement Test.
2. Per DM 54, s. 2019 entitled "Schedule of the Administration of National Assessment of Student Learning for the K to 12 Basic Education Program", an advisory or memorandum on specific date of test administration shall be issued.
3. Based on DepEd Order No. 55, s. 2016 entitled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program, the following may register for the PEPT:
 - a. Learners from schools without government permit,
 - b. Learners from nonformal and informal education programs,
 - c. Learners who have incomplete or no record of formal schooling,
 - d. Learners with back subjects,
 - e. Learners who need grade level standards assessment, and
 - f. Learners who are over-age for their grade levels.
4. Registration shall be at the Schools Division Office. Submission of complete documentary requirements of each registrants shall be **on or before September 30, 2019**, which include the following:
 - a. School Records
 - School Form 10 (Form 137) for secondary students or School Form 9 (Form 138) for elementary pupils
 - Original and 2 photocopies

Note:

 - ❖ *Form 137 or SF10: Transcript of Records with school seal and signature of principal/registrar*
 - ❖ *Form 138 or SF9: Report Card with school seal and signature of principal/registrar*
 - b. Birth Certificate - issued by the Philippine Statistics Authority (PSA) or Local Civil Registrar duly authenticated (original and 2 photocopies)
 - c. ID Pictures – two pieces, identical and recently taken 1"x1" pictures with name tag
 - d. School Permit - photocopy of School Permit to Operate/Government Recognition (for applicants from private schools)
