### 21st NATIONAL YOUTH CONGRESS

October 27-30, 2019 Cebu, Philippines

### Practical Information Guide 1

The National Youth Congress is the highest deliberative body of the Red Cross Youth which is convened biennially with qualified youth officers and members in attendance from all over the country in order to discuss relevant strategies and plans to continually intensify quality leadership among RCY's and develop youth programs for the future. The Congress, which is highly participatory, is designed to draw the youth's interest in bringing out the best in them.

#### I. OBJECTIVES:

- a. Gather chapters with active RCYs, RCY Moderators, and CSR-RCYs or Focal Persons to participate and engage in the youth congress;
- b. Share best practices of the Red Cross Youth;
- c. Discuss relevant issues concerning the youth movement;
- d. Formulate action plans and/or policy recommendations for the improvement of the Red Cross Youth and the Philippine Red Cross;
- e. Revise the Constitution and By-Laws of the National Youth Council to unify the Constitution and By-Laws of the Red Cross Youth Philippines;
- f. Recognize exemplary Chapter Service Representatives;
- g. Elect the new set of Area Youth Coordinators in line with the Constitution and By-Laws Ratified in the 20th National Youth Congress;
- h. Elect the 21st National Youth Council Officers in line with the Constitution and By-Laws Ratified in the 20th National Youth Congress;
- i. Elect the new set of Moderators' League Area Representatives;

### II. PARTICIPATION

The chapters are highly encouraged to send active Red Cross Youth volunteers giving priority to Chapter Youth Council Officers.

Each chapter can send a maximum of four (4) Youth Delegates, Eight (8) Youth Observers, one (1) RCY Moderator, and one (1) CSR-RCY. All of which shall meet the minimum requirements.

A screening committee shall be created to ensure all participants to the congress are fully eligible to participate in activities and contribute to the achievement of the objectives.

Fully accomplished registration forms shall be received by the 21st NYC Secretariat on or before the set deadline through email at nyc@redcross.org.ph, with the subject Registration\_Area\_Chapter Name (e.g. Registration\_Area1\_Baguio Chapter). There will strictly be NO on-site or walk in registration.

#### III. QUALIFICATION AND REQUIREMENTS

#### Qualifications

#### **Delegate**

- Must exemplify the principles and values of the International Red Cross and Red Crescent Movement;
- Must actively participate and contribute meaningfully to the discourse in the congress;
- Must be a bona fide Red Cross Youth member with an existing Membership Accident Assurance Benefit (MAAB);
- Must be from an accredited school, community, or chapter youth council;
- Must be a Chapter Youth Council Officer;
- Must be 15 to 30 years old;
- Must be physically and mentally fit as certified by a medical certificate;
- Must have completed the Leadership Development Program (strictly required);
- Must be actively involved in RCY activities for a minimum of two (2) years as certified by the CSR-RCY, noted by the Chapter Administrator;
- For those aged 15 17, must secure a parent's waiver.

#### Observer

- Must exemplify the principles and values of the International Red Cross and Red Crescent Movement;
- Must actively participate and contribute meaningfully to the discourse in the congress;
- Must be a bona fide Red Cross Youth member with an existing Membership Accident Assurance Benefit (MAAB);
- Must be from an accredited school, community, or chapter youth council;
- Must be a Chapter Youth Council Officer, RCY Instructor, or member of the Council of Presidents;
- Must be 15 to 30 years old;
- Must be physically and mentally fit as certified by a medical certificate;
- Must have completed the Leadership Development Program (strictly required);
- Must be actively involved in RCY activities for a minimum of one (1) year as certified by the CSR-RCY, noted by the Chapter Administrator,
- For those aged 15 17, must secure a parent's waiver.

### **RCY Moderators**

- Must exemplify the principles and values of the International Red Cross and Red Crescent Movement;
- Must be a bona fide Red Cross Youth Moderator with an existing Membership Accident Assurance Benefit (MAAB);
- Must have attended the Council Management Training for Moderators;
- Must provide a certification duly signed by the School Head, noted by CSR and CA;
- Must be physically and mentally fit as certified by a medical certificate;
- Must be from an accredited school or community council.

### Requirements for the Youth Delegates and Observers:

- 1. Duly accomplished Application Form;
- 2. Photocopy of existing MAAB ID;
- 3. Photocopy of LDP Certificate;
- 4. Certificate of Service years duly signed by the CSR-RCY, noted by the Chapter Administrator;
- 5. Medical Certificate (within 6 months);

### Requirements for RCY Moderators:

- 1. Duly accomplished Application Form;
- Photocopy of existing MAAB ID;
- Photocopy of CMT Certificate;
- 4. Certificate of Service years duly signed by the CSR-RCY, noted by the Chapter Administrator;
- 5. Medical Certificate (within 6 months);

### Requirements for CSR-RCY or Focal Person:

- 1. Duly accomplished Application Form;
- 2. Photocopy of existing MAAB ID or Philippine Red Cross ID;
- 3. Medical Certificate (within 6 months);

### IV. REGISTRATION FEES

Each participant [Delegates/Observers/Moderators/CSRs] shall pay a registration fee of:

The registration fee shall cover the venue rental, conference kits and other necessary materials that may be needed for their participation in the activities. However, it will not cover the travel expenses of the participants to and from the venue. The host chapter shall arrange transportation from the terminal to the designated venue and vice versa. The participants are encouraged to seek for sponsorship from their school, community, civic organizations, local government units or chapter funds, if available.
