- The Department of Education (DepEd), through the Bureau of Education Assessment (BEA) shall administer the **Philippine Educational Placement Test** (**PEPT**) on **November 24, 2019**, Sunday, 7:30 A.M., at Kalibo Elementary School, Kalibo, Aklan.
- During the examination day, the examinees are advised to bring No. 2 lead pencil, clean sheet of paper, sharpener, and eraser. The test takers must be at the testing center at 7:00 in the morning. The test takers may also bring snacks and lunch that they can take during the break.
- Orientation on the administration of the 2019 Special PEPT among Division Testing Personnel shall be on November 21, 2019, 2:00 P.M., at ASJ Hall, Division Office, Kalibo, Aklan.
- PEPT Division Management Committee is found in Enclosure No. 1.
- 5. Teacher-examiners are entitled to Service Credits where they apply in accordance with DepEd Order No. 53, s. 2013 entitled: "Updated Guidelines on the Grant of Vacation Service Credits for Teachers." On the other hand, non-teaching personnel including the management staff shall be provided with Compensatory Time Off (CTO) as per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Teaching Monetary Remuneration for Overtime Service Rendered.
