**BINHI: GULAYAN SA TAHANAN CHALLENGE**

1. The recognition of the implementers shall focus on vegetable production of Gulayan sa Tahanan.
2. The Public Schools District Supervisor will select two schools (1 for elementary and 1 for secondary) to participate in the said challenge and shall submit an endorsement letter and parental consent using the **link [bit.ly/BINHIGSTC22](https://bit.ly/BINHIGSTC22) on or before February 18, 2022.**
3. The participant/s to this activity are learner/s from the selected schools and the challenge is to create and sustain a vegetable garden at their respective home/backyard.
4. Garden tools and seeds were provided by this office under the Youth Formation Program Support Fund CY 2021.
5. The challenge will start in **February 2022** and participant/s shall post 1-3 minutes of documented video at their **DepEd Tayo – Youth Formation School Page on July 6, 2022** with the subject BINHI: Gulayan sa Tahanan Challenge, their name, district and hashtags: #depedaklan #depedkabataan2022 #yfd #BINHI:GulayanSaTahananChallenge #highschool (to be used by secondary participants) #elementary (to be used by elementary participants) .
6. The video must be informative, instructional, and/or entertaining and must not contain any malicious and offensive content.
7. Criteria:
  - a. Methodology (promotion of ecologically friendly practices & approaches)- 30%
  - b. Quality and aesthetic impact (arrangement and suitability of the plants)- 10%
  - c. Sustainability (period or time frame per harvest and plan of action)- 30%
  - d. Variations (interplay of vegetables)- 20%
  - e. Cost efficiency (minimal or no expenses incurred)- 10%
8. The following are the modes of verification:
  - a. Methodology - video of the process involved in operation of the garden
  - b. Quality and Aesthetic impact – video of the result of gulayan sa tahanan
  - c. Sustainability – project timeline
  - d. Variations – list of vegetables planted in the gulayan
  - e. Cost efficiency – utilization of recyclable materials

9. There shall be top three (3) winners and shall be awarded of the following prizes:
  - a. 1st Place = Php3,000.00 worth of school supplies, garden tools and seeds
  - b. 2nd Place = Php2,000.00 worth of school supplies, garden tools and seeds
  - c. 3rd Place = Php1,000.00 worth of school supplies, garden tools and seeds
  - d. Special Category: People's Choice Award = Php500.00 worth of school supplies, garden tools and seeds
10. The counting of most viewed entry for People's Choice Award will be on **July 27, 2022**.
11. Other expenses incurred in the operation of the Gulayan sa Tahanan Challenge will be shouldered by the implementers. Linkage with LGUs, government agencies and NGOs for support and sustainability is encouraged.
12. Failure to comply with any requirements set by the guidelines will automatically lead to disqualification.
