Greetings from ABC+!

Part of the project deliverables is mobilizing stakeholder and community support to early grades, literacy and socio-emotional development skills of school children. In order for the project to determine appropriate interventions, a baseline study will be conducted with The Asia Foundation as the project strategic partner and the University of the Philippines Visayas Foundation, Inc. (UPVFI).

Specifically, UPVFI study will focus on determining the following:

1. Key characteristics of Western Visayas socio-economic landscape affecting the implementation of MTB-MLE;
2. Features of the basic education structure that affect decision making with respect to resources needed to support implementation of MTB-MLE; and,
3. Identification of the stakeholders in the implementation of MTB-MLE, the level of influence, and their motivations that can be tapped to support MTB MLE implementation.

UPVFI will conduct an in-depth interview with selected Public School District

Supervisors and School Principals on the dynamics of implementing MTB MLE, local government officials on the processes and dynamics of decision making in local school boards with respect to SEF allocation; and, conduct FGDs with parents, teachers and school administrator on the dynamics and challenges of implementing MTB MLE.




