CONDUCT OF EARLY REGISTRATION FOR SCHOOL YEAR 2019-2020

- To: Chief Education Supervisors
 Education Program Supervisors
 Public Schools District Supervisors

 District ICT Coordinators
 All Other Concerned
- 1. Pursuant to DepEd Order No. 03, 2018, entitled "BASIC EDUCATION POLICY", this office hereby informs the field of the commencement of Early Registration for Kinder to Grade 12 on January 26, 2019, in all public elementary and secondary schools for SY 2019-2020 to ensure maximum inclusive participation of all learners.
- 2. The early registration of incoming Kindergarten, Grades 1, 7, and 11 learners in public schools shall be conducted from January 26, 2019 to February 22, 2019. Incoming Grades 2-6, Grades 8-10 and Grade 12 are considered pre-registered, thus there is no need for these learners to participate except for transferees.
- Early registration is conducted to achieve the following:
 - a. Ensure all new entrants for Kindergarten, Grade 1, 7 and 11 learners are registered; and
 - b. Locate, identify and register OSC and OSY in the community who may be characterized as:
 - * Living with disability/ies
 - * Living in an off-grid community
 - * Living in a barangay without a school
 - * Living in a geographically isolated area
 - * Displaced due to natural disaster
 - * Living in an armed conflict area
 - * Living in an area with high level of criminality/drug abuse
 - * Having chronic illness
 - * Having nutritional problem/s
 - * Victim of child abuse, economic exploitation
 - * Stateless/Undocumented
 - * In conflict with the law
 - * Living on the streets
 - * No longer in school but interested in going back to school

- 4. Further, school heads are advised to encode the registrants in the Learners Information System (LIS) from January 26 to February 9, 2019.
- 5. Each school shall designate Early Registration Desks or Registration Centers in the school premises and individuals who will handle registration.
- 6. All schools led by the School Heads and District Supervisors shall conduct an information dissemination, advocacy campaign activities such as tarpaulin display, signage, public announcement and meetings involving parents in the community, local officials, civic organizations and other stakeholders to raise public awareness of early registration.
- 7. Attached is the Division Monitoring Team who will be monitoring the conduct of the first day of 2019 Early Registration on January 26, 2019.
- 8. Division Monitoring Team and school heads who will serve on this activity shall be provided with Compensatory Time-Off (CTO) per Civil Service Commission (CSC) and DBM Joint Circular No. 2, s. 2004, entitled "NON-MONETORY RENUMERATION OF OVERTIME SERVICE RENDERED" and to teachers, they shall be provided service credits per DO 53, S. 2003, entitled "UPDATED GUIDELINES ON GRANT OF VACATION SERVICE CREDITS TO TEACHERS AMENDED BY DO 84, S. 2003 ADDENDUM TO DEPED ORDER NO. 53, S. 2003 (UPDATED GUIDELINES ON GRANT OF VACATION SERVICE CREDITS TO TEACHERS) DO 5, S. 2004 ELIGIBILITY OF REMEDIAL INSTRUCTION CLASSES FOR GRANT OF VACATION SERVICE CREDITS.
- 7. Immediate and widest dissemination of this Memorandum is desired.
