**CONDUCT OF RECALIBRATION FOR THE REMAINING JUNIOR HIGH SCHOOL
TEACHER I POSITIONS FOR SCHOOL YEAR 2019-2020**

All Others Concerned**

1. This is to announce to the field that per DepED Order No. 22, s. 2015, "Hiring Guidelines for the Remaining Teaching Positions Effective School Year (SY) 2015-2016", there will be recalibration of points of Junior High School Teacher I applicants in the following subject areas/specializations:
 - a. Edukasyon sa Pagpapakatao (EsP);
 - b. Araling Panlipunan/Social Science;
 - c. TLE-Industrial Arts;
 - d. TLE-ICT;
 - e. TLE-Agri/Fishery
 - f. Chemistry;
 - g. General Science; and
 - h. Music, Arts, Physical Education and Health (MAPEH).

2. **Applicants in these subject areas/specializations who have undergone the evaluation process (January-March 2019) for school year 2019-2020** per DepED Order No. 7, s. 2015 but were not included in the initial Registry of Qualified Applicants (RQA) are advised to submit any or all of the following documents, if available:
 - a. Certified copy of Updated Service Record or Certification of Teaching Experience as of **June 30, 2019**;
 - b. Certified copy of Updated Transcript of Record as of **June 30, 2019** (Certification is not accepted);
 - c. Certificate of Specialized Training related to the subject/specialization being applied for (if not yet submitted in the previous evaluation process)

3. Those applicants who have no additional experience/education/training after the previous evaluation need NOT submit for recalibration.
4. The deadline of submission of these documents will be on **August 20, 2019, 5:00 P.M., stamped "RECEIVED" at the receiving section of the Division Office.** All copies of documents shall have **already CERTIFIED by the head of the school** where the documents were submitted during the previous evaluation process. **The applicant shall be the one to submit to the division office, Attention: DIVISION SELECTION COMMITTEE,** the documents in a folder with the following information on the **first page**:
 - a. Complete name of applicant
 - b. Mobile Number of Applicant
 - c. District and school where the previous evaluation was conducted
 - d. Subject Area/s being applied for
 - e. Applicant's Complete Address (same as previous evaluation)
 - f. List of documents submitted
 - g. Signature of applicant
5. **Education Program Supervisors concerned shall take charge of the recalibration.**
6. Public schools district supervisors and school heads concerned are requested to inform immediately their respective applicants regarding this memorandum.
7. Immediate and wide dissemination of the contents of this memorandum is strongly desired.
