The DepED-Division of Aklan, through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned works. Bidding is restricted to Filipino citizens/sole proprietorships/partnerships, or organizations with at least seventy-five percent (75\%) interests or outstanding capital stocks belonging to citizens of the Philippines.
