INVITATION TO BID

The Department of Education (DepED) Division of Aklan, through the **GENERAL APPROPRIATIONS ACT (GAA) 2018**, intends to apply the **Seven Million One Hundred Sixty Two Thousand Nine Hundred Fifty Two Pesos and 80/100 (Php7,162,952.80)**, being the Approved Budget for the Contract (ABC), to eligible payments under the contract for the project **CY 2018 Basic Educational Facilities Fund (BEFF) Lot 2 – Electrification of Un-Energized Schools on-Grid at Candelaria National High School**, New Washington, Aklan; Guadalupe National High School, Libacao, Aklan; Ibajay National High School, Ibajay, Aklan; Lezo Integrated School, Lezo, Aklan; Libacao National Forestry and Vocational High School, Libacao, Aklan; and Linayasan National High School, Altavas, Aklan, under the GAA 2018. Bids received that exceed the ABC per lot shall be rejected at bid opening.

The DepED-Division of Aklan, through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned works. Prospective bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships/partnerships, or organizations with at least seventy five percent (75%) interests or outstanding capital stocks belonging to citizens of the Philippines.

A complete set of Bidding Documents may be inspected or purchased at the DepED-Division of Aklan BAC Secretariat, located at DepED Division of Aklan upon accomplishing a bidder's information sheet and payment in cash of a non-refundable fee by interested bidders in the amount of **Ten Thousand Pesos (Php10,000.00)** to the DepED-Division Cashier. Only bidders who purchased the Bidding Documents will be allowed to submit bids (ITB 6.8).

It may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), <u>www.philgeps.net</u> and DepED-Aklan website <u>www.depedaklan.org</u>, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

Bids must be delivered to the address and on the date and time stated herein. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. A valid Bid Securing Declaration must accompany the bid(s) in lieu of the bid security.

Bids will be opened in the presence of the bidders' representatives who choose to attend the opening of bids at the address stated herein. Late bids shall not be accepted.

The DepED-Division of Aklan reserves the right to reject any and all bids, declare a failure of bidding, not award the contract(s), or annul the bidding process without thereby incurring any liability to the affected bidder or bidders.
