The Department of Education Division of Aklan, through its Bids and Awards Committee (BAC) intends to apply the sum of **Five Hundred One Thousand Pesos Only (Php501,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contracts for **SUPPLY AND DELIVERY OF IT EQUIPMENT** as follows:

NAME OF PROJECT : Supply and Delivery of IT Equipment

FUNDING SOURCE : Government of the Philippines (GoP) 2019 – Capital Outlay - ES

CONTRACT DURATION: 45 Calendar Days

DELIVERY SITES : "Door to door" delivery to the recipient school

The Department of Education Division of Aklan, through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned works. Bidders should have completed, within six (6 months to one (1) year) from the date of submission and receipt of the bids, a contract similar to the project. The description of an eligible bidder is contained in the bidding documents, particularly, in Section II. Instruction to Bidder. Bids received that exceed the total ABC shall be rejected at bid opening. Late bids shall be rejected. Evaluation and award shall be made on a per lot basis.

Open competitive bidding will be conducted using the non-discretionary pass/fail criterion, evaluation and post-qualification procedures specified in the Implementing Rules and Regulations (IRR) of R.A. 9184. Information is also available at <a href="https://www.philgeps.net">www.philgeps.net</a>.

In addition, select one of the two following paragraphs and delete the other depending on the existence of conditions under Section 23.5.1.2 of the IRR of RA 9184:

Select this paragraph if conditions (a), (c), and (d) under Section 23.5.1.2 of the IRR of RA 9184 do not exist: Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
