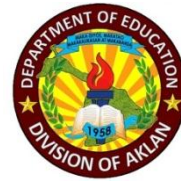

## **INVITATION TO BID FOR PROVISION OF SECURITY SERVICES OF THE DEPED- DIVISION OF AKLAN FOR 2021**

The Department of Education Division of Aklan, through the Bids and Awards Committee (BAC) intends to apply the sum of **Seven Hundred Twenty Thousand Pesos Only (Php720,000.00)** being the ABC to payments under the contract for **PROVISION OF SECURITY SERVICES OF THE DEPED-DIVISION OF AKLAN FOR 2021**. Bids received in excess of the ABC for each lot shall be automatically rejected a bid opening.

1. The Department of Education Division of Aklan through its Bids and Awards Committee (BAC) now invites bids for the above-mentioned Procurement Project. Delivery of the **SERVICES** is required by **March 1, 2021 to December 31, 2021**. Bidders should have completed, within **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
2. The Department of Education Division of Aklan now invites bids for the above Procurement Project. Delivery of services is required by March 1, 2021 to December 31, 2021. Bidders should have completed within three years from the date of submission of receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is any Filipino citizen or corporation, association, partnership, one hundred percent (100%) of which is owned and controlled by Filipino citizens.
4. Prospective Bidders may obtain further information from Department of Education Division of Aklan – Bids and Awards Committee and inspect the Bidding Documents at the address given below, **from Monday to Friday except holidays, 8:00 A.M to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **January 29, 2021 to February 17, 2021** from the given address and website(s) below, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest guidelines issued by GPPB in the amount of **One Thousand Pesos Only (1,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person along with the submission of its bids.
6. The Department of Education Division of Aklan will hold a Pre-Bid Conference on **February 5, 2021, 9:00 A.M. at ASJ Hall, Old Division Office Building, Kalibo, Aklan** which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat **through manual submission at the office address indicated below from 8:00 am -5:00 pm January 29, 2021 to February 16, 2021 and from 8:00-8:45 a.m. on February 17, 2021. Online or electronic submission is not allowed.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **February 17, 2021, 10:00 A.M at ASJ Hall, Old Division Office Building, Kalibo, Aklan.** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Department of Education Division of Aklan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
