Bids received that exceed the total ABC shall be rejected at bid opening. Late bids shall be rejected. Evaluation and award shall be made on a per lot basis.

Open competitive bidding will be conducted using the non-discretionary pass/fail criterion, evaluation and post-qualification procedures specified in the Implementing Rules and Regulations (IRR) of R.A. 9184. Information is also available at [www.philgeps.net](http://www.philgeps.net).
