Bidders should have completed, within six (6) months to one (1) year) from the date of submission and receipt of the bids, a contract similar to the project. The description of an eligible bidder is contained in the bidding documents, particularly, in Section II. Instruction to Bidder. Bids received that exceed the total ABC shall be rejected at bid opening. Late bids shall be rejected. Evaluation and award shall be made on a per lot basis.

Open competitive bidding will be conducted using the non-discretionary pass/fail criterion, evaluation and post-qualification procedures specified in the Implementing Rules and Regulations (IRR) of R.A. 9184. Information is also available at www.philgeps.net.
