In view of my personal travel to Spain on September 8 to 28, 2017, you are hereby designated as Officer In Charge of the Office of the Provincial Governor, Province of Aklan effective as to the dates of my travel until my return to station.

In the performance of your duties as Officer In Charge, Office of the Provincial Governor, you will discharge only the following functions and duties:

- a) Sign and approve vouchers and checks for the payment of salaries
 of provincial employees and other regular expenses;
- b) Attend conferences as well as other ceremonial functions in representation of the Office of the Provincial Governor;
- c) To perform routinary and administrative functions such as supervision of the day-to-day operations of the office of the local chief of executive.

You shall, however, inhibit yourself from acting upon transactions which are policy-determining, confidential and highly technical in nature, and upon those involving contracts, appointments and dismissal of casuals. These should be held in abeyance until my return to station.

In the performance of your routinary functions, you shall sign papers, thus;
