

Speech and Verbal Communication - Pronunciation

Course Description

This course deals with the enhancement of the teachers' skills in the art of speech and verbal communication as well as their abilities in identifying mispronounced words through familiarization of the IPA symbols and sounds.

Course Outcome

This course helps the teachers to:

Be familiar with the IPA symbols and sounds

Be keen in identifying mispronounced words

Master the skills in reinforcing and redirecting students' pronunciation

Strengthen the language program of the school to produce an English-speaking community

Module 1: Correct Pronunciation (3 hrs and 30 mins)

1.1 Learning Objectives:

At the end of the module, the learners will:

- Match the word with name of the sound for each underlined syllable.
- Name the Standard American vowel and consonant sounds.
- Identify the steps needed to correctly produce sounds.
- Correctly produce the sound of the words in a given sentence.

Module 2: Watchful Ears (1 hr and 30 mins)

2.1 Learning Objectives:

At the end of the module, the learners will:

- Identify mispronounced vowel and consonant sounds in words and sentences.
- Determine what caused the incorrect pronunciation of the identified mispronounced sounds.

Module 3: Effective Reinforcement and Redirection (2 hrs and 30 mins) 3.1 Learning Objectives: At the end of the module, the learners will: Reinforce the correct pronunciation of the participants.

Redirect a speaker who is mispronouncing words.
