

2017 MATHEMATICS TRAINERS' GUILD QUALIFYING EXAMINATION
AND TRAINING PROGRAMS

The *Mathematics Trainers' Guild (MTG) Philippines* will conduct its *2017 Qualifying Examination* on July 15, 2017 in different MTG training centers in the Philippines.

The Qualifying Examination aims to:

1. evaluate the breadth of the students' mathematical knowledge and skills;
2. select superior students in the field of Mathematics for further training and advancement;
3. provide them with the appropriate venue to enhance their Mathematics skills through phases of trainings; and
4. develop the Mathematics potentials of promising Mathematics students to meet international mathematics standards.

The target participants are mathematically inclined and gifted elementary and junior high school learners from public and private schools.

The Philippine Board of Studies Foundation (PBOSF) Inc. will sponsor the registration fees of public school learners in the Qualifying Examination.

Those who will pass the Qualifying Examination, shall be eligible to enrol in the following *MTG training programs* for School Year 2017-2018:

1. *Mathematical Challenge for Filipino Kids Training Program (MCFKTP)*. This has a total of 12 Saturday sessions that are usually conducted for three hours within the academic year;
2. *Young Mathematical In-house Intensive Training Program (YMIITP)*. This is a four-day in-house intensive training program where the MCFKTP top scorers are invited to attend and are given lectures and battery of quizzes and examinations to select the qualifiers and alternates; and
3. *Mathematical Olympiad Summer Training Program (MOSTP)*. This is a month-long training for YMIITP qualifiers and alternates who will be equipped with advanced math contents, concepts and strategies in preparation for their participation in different international contests.

Participation of both public and private schools shall be subject to the *no-disruption-of-classes policy* stipulated in DepEd Order No. 9, s. 2005 entitled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith*.
