1. Pursuant to Regional Memorandum No. 137, s. 2021, dated March 31, 2021 titled "Regional ARTS CONTEST IN CELEBRATION OF THE 65TH ANNIVERSARY OF PEACE TREATY BETWEEN PHILIPPINES AND JAPAN" the Division of Aklan will conduct a contest on April 20, 2021 to choose the best who will represent the division in the regional level competition with the theme "Dakilang Lahi".

2. The activity aims to showcase the talents in painting of both learners and teachers and to uncover their own perspective through their artwork on the importance of the diplomatic relations between the Philippines and Japan.

3. Rules and mechanics of the contest:

a. There are three categories: elementary learner, high school learner and teacher.

b. All entries/paintings shall be original on a canvas with 24x36 inches frame, using only acrylic or oil paint.

c. The champion in each category shall represent SDO-Aklan to the Regional Arts Contest on April 28, 2021.

d. Division winners will receive a Certificate of Recognition while a Certificate of Participation will be given to the non-winners.

e. The criteria for judging are as follows:

Relevance to the Theme.....	35%
Originality	30%
Creativity and Presentation.....	25%
Over-all Impact	10%
