2. Participants are also reminded of the provision of DepEd Task Force COVID-19 Memorandum No. 575, dated 07 December 2021 titled IATF Vaccination Requirement for Personnel reporting On-site Beginning 01 December 2021, particularly **Paragraph 3, letter e.i.,** to wit:

Paragraph 3: Consistent with IATF Resolution Nos. 148-B and 149, s. 2021, the following shall be observed in DepEd:

e. For consistency, the same requirement—that they are either fully vaccinated or RT-PCR/antigen-negative, as described above—shall be imposed on:

i. Personnel required to travel or attend a work-related

 Personnel required to travel or attend a work-related face-to-face gathering (e.g., seminar, training, monitoring, worship, forum, meeting);

- 3. Proper health and safety protocols shall be strictly observed during the conduct of the activity.
- 4. Expenses incurred relative to food allowance and travel expenses of participants shall be charged against school MOOE while that of division office shall be charged against division MOOE subject to the usual accounting and auditing rules and regulations.
- Wide dissemination of this Memorandum is desired.
