- 2. At the end of this activity, the participants are expected to:
 - a. Demonstrate understanding of the Division, District and School MEA framework;
 - b. Describe the process flow of MEA in the schools, districts and in the division:
 - c. Commit to transfer mea technology in the schools; and
 - d. Develop implementation plan on MEA in the division, districts, and schools
- 3. The participants to this activity are key division office personnel to be identified by the SDS and school heads to be identified by the PSDS/PID/HTID. The names of the identified school head participants shall be submitted to Miss Rita M. Rey, SEPS for M&E on or before August 28, 2018. The number of slots per district is considered procured so that those who will not be able to attend shall be made to pay the full amount of registration fee.
- 4. Each school head is advised to bring the following:
 - a. School Improvement Plan
 - b. School Report Card
 - c. Other documents containing the last 3 years of important KPIs
 - d. School heads supervisory reports
 - e. Laptop and extension cord
- 5. School heads shall be charged a registration fee of Nine hundred twenty pesos (Php 920.00) each to cover expenses for meals, supplies, accommodation, rentals, and others. The registration fee, travel and other allowable expenses relative to the attendance to this activity may be charged against local funds subject to the usual accounting and auditing rules and regulations.
- 6. One-day service credit or compensatory time off will be given to those who are entitled and who will attend on September 8, 2018, subject to the provisions of applicable DepED, CSC, and other issuances.
