

**DIVISION TRAINING OF ATHLETES AND PARTICIPATION TO THE 2020 WESTERN VISAYAS
REGIONAL ATHLETIC ASSOCIATION (WVRAA) MEET**

1. The Western Visayas Regional Athletic Association (WVRAA) Meet will be held at Aklan Sports Complex, Calangcang, Makato, Aklan on March 21-28, 2020 to be hosted by the Province of Aklan and DepEd-Division of Aklan.
2. To ensure the success of our participation to said event, the in-house training of athletes will resume on March 12, 2020 and this will continue until the duration of the competition on March 21-28, 2020. The billeting quarters will be at Numancia Integrated School, Numancia, Aklan. All athletes, coaches, chaperons and trainers shall again register for record purposes at the Administrative Office of Numancia Integrated School before proceeding to their assigned rooms.
3. The training staff, school health services section staff and mess personnel are expected to report to their respective billeting quarters in the morning of March 11, 2020 while the athletes, coaches, chaperons and trainers shall be at their billeting quarters in the morning of March 12, 2020. The first meal will be lunch on the date of arrival.
4. Participation of learners to this activity is subject to compliance with the guidelines on off-campus activities as stipulated in DepEd Order No. 66, s. 2017 (IMPLEMENTING GUIDELINES ON THE CONDUCT OF OFF-CAMPUS ACTIVITIES).
5. As stated in Regional Memorandum No. 141, s. 2019 titled " Reiterating Policies for Contestants and Athletes Participating on Higher Competitions", "participating athletes/ contestants in the higher meets shall be given adequate time for taking graded test, or be given Special outputs compensatory to what they missed.
