1. This is to inform the field that there will be a **Division Training-Workshop on the Bureau of Learning Resources (BLR) Standards and Guidelines on Visual Arts on November 4-6, 2019** at Adee's Catering Services and Function Hall, DBP Ave., Capitol Site, Kalibo, Aklan.

- 2. This activity aims to equip coordinators and teachers with the necessary knowledge, skills and attitudes on the updated standards and guidelines on visual arts and management of visual arts for learning resources. At the end of the training, the participants are expected to submit BLR-standardized illustrations for learning resources.
- 3. Participants for the said workshop will be (1) District LR Coordinator and (2) Manual Illustrators and (1) Digital Illustrator, and (1) Layout Artist designated by the District. "NO DISRUPTION OF CLASSES" POLICY SHALL BE STRICTLY OBSERVED.
- 4. Each district team must bring the following:
 - a. Laptop with charger and, if possible, at least 2-gang extension cord;
 - i. The Laptop must have Adobe Photoshop (at least CS 3) installed
 - b. Soft copy of a storybook to be illustrated
 - c. Art Materials for Line Drawing (Pens and Markers)
 - d. Digital/Mobile Camera
- 5. Training expenses of participants shall be charged against the division INSET/HRTD funds. Travel expenses of participants may be charged against school MOOE funds, subject to the usual accounting and auditing rules and regulations.
- 6. The participants and facilitators will be given service credits/compensatory time off as per DepEd Order 53, s. 2003, Updated Guidelines on the Grant of Service Credits.
- Immediate and widest dissemination of this Memorandum is desired.
