The members of the Division Development Team of LRs are entitled to Service Credits for their services rendered during weekends and holidays but not to exceed 15 days per year in accordance with DepEd Order No. 53, s. 2003 titled: Updated Guidelines on the Grant of Vacation Service Credits to teachers. On the other hand, non-teaching personnel shall be provided with Compensatory Time Off (CTO) for their services rendered during weekends and holidays per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered. The giving of the said Service Credits/Compensatory Time Off shall reckon from the time that the development teams have started their development works in quarter 1 depending on the number of LRs developed and quality assured. The management team shall have prepared attendance sheet/logbook for the team members to record their actual time to this effect.

It is understood that in the conduct of this activity there shall be no discrimination on provision of learning and Development interventions on account of age, school, gender, civil status, disability, religion or other similar factors/personal circumstances that run to the principles of equal opportunity.

7. The participants of this activity shall strictly adhere to the health protocols in accordance to DO No 14, s. 2020 titled: Guidelines on the Required Health Standards in Basic Education Offices and Schools.

8. Expenses relative to the conduct of the activity shall be charged to Local Funds subject to the usual accounting and auditing rules and regulations.

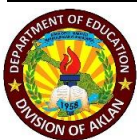
