By virtue of the aforementioned authority granted by COMELEC to DepEd to ensure compliance with and enforcement of all orders and instructions relative to the election duties of the latter's personnel to ensure free, orderly, honest, peaceful and credible elections, the 2018 DepEd Election Task Force (ETF) Operation and Monitoring Center for the May 14, 2018 Barangay and Sangguniang Kabataan (SK) Elections shall be established at the ASJ Hall of the Division Office, Arch. Gabriel M. Reyes St., Poblacion, Kalibo, Aklan, which starts at 2:00 PM of 13 May 2018 and ends on 12:00 NN of 15 May 2018.
