# ESTABLISHMENT OF THE 2019 DEPED ELECTION TASK FORCE AND ITS OPERATION AND MONITORING CENTER IN THE SCHOOLS DIVISION OFFICE IN CONNECTION WITH THE MAY 13, 2019 NATIONAL AND LOCAL ELECTIONS

- 1. Pursuant to Article IX-C, Section 2 (4) of the 1987 Philippine Constitution, the Commission on Elections (COMELEC) has the power to deputize law enforcement agencies and instrumentalities of the government for the exclusive purpose of ensuring free, orderly, honest, peaceful and credible elections.
- 2. The Department of Education (DepEd) is one of the national agencies deputized by COMELEC to ensure free, orderly, honest, peaceful and credible elections, through the appointment of public school teachers to serve as chairpersons and members of the Electoral Board.
- 3. By virtue of the aforementioned authority granted by COMELEC to DepEd to ensure compliance with and enforcement of all orders and instructions relative to the election duties of the latter's personnel to ensure free, orderly, honest, peaceful and credible elections, the 2019 DepEd Election Task Force (ETF) Operation and Monitoring Center for the May 13, 2019 National and Local Elections shall be established at the Arthur S. Juada (ASJ) Hall of the Division Office, Arch. Gabriel M. Reyes St., Poblacion, Kalibo, Aklan, which starts at 1:00 P. M. of 12 May 2019 and ends at 5:00 P. M. of 14 May 2019.

4. The Division ETF shall be composed of the following, to wit:

## Duties and Funftions of each Committee 2019 DepED Election Task Force

#### Steering

- provides direction and over-all management and supervision

#### **Operations**

- oversees day-to-day activities and procedures
- ensures supply of energy and water
- sees to it that the venue is safe, secure and conducive
- restrooms, ventilation and convenient working place
- informs the schools and districts of communication access to the TF

#### center

- maintains cleanliness and orderliness of the work place

#### Secretariat

- checks attendance (provide attendance monitor sheet)
- provides signages to the control room and every working table
- informs Public Attorney's Office (PAO) and task force members
- maintains logbook for incident reports
- maintains day-to-day minutes of proceedings
- provides and collects DTR of members for consolidation and

# submission to Logistics and Support Unit

- provides contact numbers of COMELEC, PNP, PAO and other
- important stakeholders including media
- provides list of clustered precincts including names of supervisors and BEIs to the call center monitoring and date base
  - keeps records of all COMELEC resolutions

# Call Center Monitoring Data Base Unit

- provides telephone, fax machines, and other communication facilities including wi-fi access
  - provides portable radio and TV sets

# External Coordination Mobile Unit

- provides transportation services to task force members
- does the monitoring of schools and precincts through roving

#### Logistics and Support Unit

- provides meals and refreshments to the center
- ensures related expenses are subject to accounting and auditing rules and regulations

# Teacher Defense, Legal and Technical Unit

- provides legal and technical assistance to DepED

### Medical Services Unit

-ensures health and wellness of teaching and non-teaching personnel serving in the elections
