AN ORDER ADOPTING THE GUIDELINES ON THE IMPLEMENTATION OF ALERT LEVEL SYSTEM 1 IN THE PROVINCE OF AKLAN AS MANDATED BY THE INTER-AGENCY TASK FORCE FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES (IATF-EID)

WHEREAS, on February 27, 2022, the IATF-EID in Resolution No. 163-A placed several provinces, HUCs and ICCs including the Province of Aklan under Alert Level 1:

WHEREAS, pursuant to the Guidelines on the Nationwide Implementation of Alert Level System for COVID-19 Response as of December 14, 2021, issued by the National IATF-EID areas under Alert Level 1 shall observe protocols embodied therein;

NOW THEREFORE, I, FLORENCIO T. MIRAFLORES, Governor of the Province of Aklan, by virtue of the power vested in me by law do hereby ORDAIN:

SECTION 1. INTRAZONAL AND INTERZONAL MOVEMENT. Interzonal and intrazonal movement shall be allowed without regard to age and commorbidities.

SECTION 2. OPERATION OF ALL PUBLIC AND PRIVATE ESTABLISHMENTS AND ORGANIZERS OF EVENT SHALL IMPLEMENT THE FOLLOWING PROTOCOLS:

- A. All private offices and workplaces, including public and private construction sites, may operate at full (100%) capacity, consistent with national issuance on vaccination requirements for on-site works.
- B. Agencies and instrumentalities of the government shall adhere to 100% on-site workforce.
- C. Public transportation shall be at full (100%) seating capacity.
- D. The use of foot baths, disinfection tents, misting chambers, or sanitation booths for preventing and controlling COVID-19 transmission are not recommended. Temperature checking prior to the entry in any establishments will be optional.
- E. The use of plastic/acrylic barriers/dividers are optional as appropriate.
- F. Individuals eighteen (18) years old and above are required to present proof of full vaccination before participating in mass gatherings or entry into indoor establishments, such as but not limited to:

- Dine-in services in food preparation establishments such as kiosks, commissaries, restaurants, and eateries.
- b. Film, music, and television production.
- Fitness studios, gyms, and venues for non-contact exercise and sports.
- d. Venues for all contact sports approved by the LGU where such games shall be held.
- Venues for meetings, incentives, conferences, and exhibitions.
- f. Permitted venues for social events such as parties, wedding receptions, engagement parties, wedding anniversaries, debut and birthday parties, family reunions, and bridal or baby showers.
- g. Visitor or tourist attractions such as libraries, arc hives, museums, galleries, exhibits, parks, plazas, public gardens, scenic viewpoints or overlooks, and the like.
- h. Amusement parks and theme parks.
- Recreational venues such as internet cafes, billiard halls, amusement arcades, bowling alleys, skating rinks, archery halls, swimming pools, and similar venues.
- Cinemas and movie houses.
- k. Personal care establishments such as barbershops, hair spas, hair salons, and nail spas, and those offering aesthetic/cosmetic services or procedures, make-up services, salons, spas, reflexology, and other similar procedures including home service options.
- Venues with live voice or wind-instrument performers and audiences such as in karaoke bars, bars, clubs, concert halls, and theaters.
- m. Funfairs/peryas and kid amusement industries such as playgrounds, playrooms, and kiddle rides.
- Casinos, horse racing, cockfighting, operation of cockpits and e-sabong, lottery and betting shops, and other gaming establishments.
- In-person religious gatherings; gatherings for necrological services, wakes, inurnment, and funerals for those who died of causes other than COVID-19 and for the cremains of the COVID-19 deceased.
- Indoor ancillary establishments in hotels and other accommodation establishments
- g. Venues for election-related events.

SECTION 3. CURFEW. No curfew hours shall be implemented or observed during the effectivity of this Executive Order.

All business establishments (public or private) and activities may be conducted 24/7 (24 hours per day and 7 days a week).

SECTION 4. LIQUOR DISPENSATION AND CONSUMPTION. The selling, dispensing, transporting and consumption of liquor or alcoholic beverages or any alcoholic drink containing a specific percentage of alcohol by volume or weight which may be in the form of whisky, brandy, gin, rum, cordial, liquor, cocktail, wine, champagne, vermouth, basi, tuba, saki, beer, ale stout shall be allowed in places like restaurants, resto bars, eateries and commissaries, EXCEPT in public plazas, gymnasiums, streets, baywalk, promenade, government buildings and structures.

SECTION 5. CONTACT TRACING MANAGEMENT. All tourists and Travelers entering the province of Aklan shall secure a "Quick Response" (QR) Code via the Online Health Declaration Card (OHDC) that can be accessed at https://www.touristboracay.com/ or https://aklan.gov.ph

While the AkQuire OHDC QR Code is auto-generated, all attached documents are still subject for review upon receipt. As such, the attachment of clear, correct and authentic documents by all Tourists, Returning Aklanons and Travelers as required hereunder is expected. Otherwise, the auto-generated QR Codes shall be automatically invalidated.

A stern warning is given to everyone who gives incorrect data or misrepresented data in their OHDC Application and be mindful of attachments that violate acceptable moral and social standards. The Provincial Government shall have the right to refuse entry and future entries to the Province of anyone violating the Contact Tracing Management contained herein.

- A. FOR RETURNING AKLANONS. Fill up OHDC Registration Form in touristboracay.com under AKLAN and attach the following requirements:
 - Philippine government-issued ID with Aklan address or Philippine Passport if OFW/ROF
 - 2. Travel details
 - Proof of Vaccination Status¹
 - a) For Fully-Vaccinated Individuals
 - VaxCertPH COVID-19 Vaccination Certificate with full vaccination status from https://vaxcert.doh.gov.ph/; or,
 - Locally-issued Vaccination Card/ID with full vaccination status and with verifiable QR Code; or, with contact details of the vaccination center; or,
 - World Health Organization International Certificates of Vaccination and Prophylaxis / Vaccination Card or Vaccination Certificate Issued Abroad.

I RESOLUTION NO. 124-B, Series of 2021, July 02, 2021...A. An individual shall be considered as having been fully vaccinated for COVID-19: i. More than or equal to 2 weeks after having received the second dose in a 2-dose series, or ii. More than or equal to 2 weeks after having received a single-dose vaccine. iii. The vaccines administered to the individual are included in any of the following: 1. Emergency Use Authorization (EUA) List or Compassionate Special Permit (CSP) issued by the Philippine Food and Drug Administration; or 2. Emergency Use Listing of the World Health Organization...

- b) For Unvaccinated or Partially Vaccinated Individuals or in absence of the above-mentioned documents in 3a:
 - RT-PCR Negative Result Certificate (saliva, nasopharyngeal or oropharyngeal) with date of extraction within 72 hours to date of travel (https://hfsrb.doh.gov.ph/list-of-licensedcovid-19-testing-facilities/)
- c) For below 12 years old
 - Please accomplish the Certificate of Undertaking Travelling with Minors template at https://aklan.gov.ph
- B. FOR TRAVELERS. Fill up OHDC Registration Form in touristboracay.com under AKLAN and attach the following requirements:
 - Proof of identification with Philippine Residency;
 - 2. Travel details;

- 3. Proof of Vaccination Status
 - a) For Fully-Vaccinated Individuals
 - VaxCertPH COVID-19 Vaccination Certificate with full vaccination status from https://vaxcert.doh.gov.ph/; or,
 - Locally-issued Vaccination Card/ID with full vaccination status and with verifiable QR Code; or, with contact details of the vaccination center; or,
 - World Health Organization International Certificates of Vaccination and Prophylaxis / Vaccination Card or Vaccination Certificate issued Abroad.
 - For Unvaccinated or Partially Vaccinated Individuals or in absence of the above-mentioned documents in 3a:
 - RT-PCR Negative Result Certificate (saliva, nasopharyngeal or oropharyngeal) with date of extraction within 72 hours to date of travel (https://hfsrb.doh.gov.ph/list-of-licensedcovid-19-testing-facilities/)
 - c) For below 12 years old
 - Please accomplish the Certificate of Undertaking Travelling with Minors template at https://aklan.gov.ph
- C. FOR FOREIGN AND DOMESTIC TOURISTS Fill up OHDC Registration Form (for both adults and children including infants) in touristboracay.com under BORACAY and attach the following requirements:
 - Proof of Identification with Philippine Residency/ Passport for Foreigners/OFWs/ROFs
 - 2. Proof of Vaccination Status
 - a) For Fully-Vaccinated Individuals
 - VaxCertPH COVID-19 Vaccination Certificate with full vaccination status from https://vaxcert.doh.gov.ph/; or,
 - Locally-issued Vaccination Card/ID with full vaccination status and with verifiable QR Code or, with contact details of the vaccination center; or,
 - World Health Organization International Certificates of Vaccination and Prophylaxis / Vaccination Card or Vaccination Certificate Issued Abroad.

- b) For Unvaccinated or Partially Vaccinated Individuals or in absence of the above-mentioned documents in 2a:
 - RT-PCR Negative Result Certificate (saliva, nasopharyngeal or oropharyngeal) with date of extraction within 72 hours to date of travel (https://hfsrb.doh.gov.ph/list-of-licensedcovid-19-testing-facilities/)
- c) For below 12 years old
- Please accomplish the Certificate of Undertaking Travelling with Minors template at https://aklan.gov.ph
- A copy of confirmed booking slip/form from a DOT-Accredited Boracay Island accommodation establishment, (Accredited & HSG compliant AEs in Boracay Island)
- 4. Roundtrip flight/travel details.

For Tourists coming from Western Visayas If using private vehicles, take a photo of the vehicle plate; If taking public transportation, use the Certificate of Undertaking for Travel Details Template in https://aklan.gov.ph under Tourism.

- D. FOR AKLANON TOURISTS residing in Aklan. Fill up OHDC Registration Form in touristboracay.com under BORACAY and attach the following requirements:
 - Philippine government-issued ID with Aklan address;
 - 2. Proof of Vaccination Status
 - a) VaxCertPH COVID-19 Vaccination Certificate with full vaccination status from https://vaxcert.doh.gov.ph/; or,
 - b) Locally-issued Vaccination Card/ID with full vaccination status and with verifiable QR Code or, with contact details of the vaccination center; or,
 - World Health Organization International Certificates of Vaccination and Prophylaxis / Vaccination Card or Vaccination Certificate issued Abroad.
 - A copy of confirmed booking slip/form from a DOT-Accredited Boracay Island accommodation establishment, (Accredited & HSG compliant AEs in Boracay Island) or in the absence of hotel booking confirmation, please use the Certificate of Undertaking for Accommodation template in https://aklan.gov.ph under Tourism

Travel details. If using private vehicles, take a photo of the vehicle plate; If taking public transportation, use the Certificate of Undertaking for Travel Details Template in https://aklan.gov.ph under Tourism.

E. MANDATORY USE OF AkQuire OHDC QR Code.

- All airlines, commercial or chartered, shall scan the screenshot of QR Code or copy of OHDC of their passengers before boarding.
- All companies offering helicopter and/or seaplane services to Boracay Island shall submit copies of OHDC QR Codes of their passengers before issuance of Certificate of landing. All Helipad

- Operators are mandated to scan the screenshot of QR Code or copy of OHDC of their passengers upon disembarkation.
- All business establishments in Boracay Island are mandated to scan the screenshot of QR Code or copy of OHDC of their guests before availment of services. They are likewise allowed to apply for OHDC in behalf of their clientele.
- Accommodation Establishments in Boracay Island are enjoined to assist their clienteles in applying for OHDC QR Code.
- All ports of entry and exit to and from Boracay Island are mandated to scan the screenshot of QR Code or copy of OHDC of all port users.

SECTION 6. PENAL CLAUSE. Non-compliance with the provisions of this Executive Order shall be dealt with in accordance with existing laws, republic acts, issuances, memoranda or order of the duly constituted authorities.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect on March 1, 2022.
