Please be informed that there will be a face-to-face meeting of the Technical Working Group for the 2021 Virtual Division Schools Press Conference on November 26 and 27, 2021 from 8:00 AM to 5:00 PM at TBI/RBI Room, Old Division Office, Kalibo, Aklan.

Compliance with health and safety protocols are to be observed as articulated in the Inter-Agency Task force (IATF) Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with amendments as of June 30, 2021 as well as the existing health protocols in the locality.

The management team shall have prepared attendance sheet/logbook for the team members to record their actual time to this effect.

There will be meal allowance provided for the participants on-site chargeable against local fund subject in the existing accounting and auditing rules and regulations.
