We deeply empathize with the present condition of Mrs. Eufemia N. Rose, teacher at Ciriaco L. Icamina, Sr. National High School, Bulabud, Malinao, Aklan. She had undergone "Total Gastrectomy" and had been to blood transfusion of 15 bags and 5 placentas. Her findings and/or diagnosis are: 1) Gastric Mass Probably Malignant/ GIST, and 2) S/P Exploratory Laparotomy, Subtotal Gastrectomy Drain. At present, she was temporarily discharged with continuous home medication and treatment. Her hospital bills reached to almost a million of Pesos and still have an outstanding balance. Her family had spent a lot prior to her surgical operations (she had been into twice surgical operations) causing them to struggle financially to cover with the remaining hospital bills and her daily medication and treatment.

In connection to this, we do appeal for your generous financial assistance. Any financial help that you can extend to her would mean a lot to her and her family.
