
Greetings of Peace!

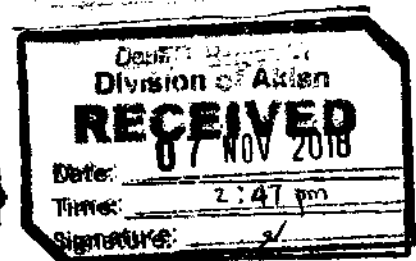
