REGIONAL MEMORANDUM

WinS Endline Survey and SBM Level of Practice

To: Schools Division Superintendents **Division SGOD Chiefs Division SBM-Wins Coordinators Division Information Technology Officers** All Others Concerned

- 1. Aimed at determining the extent of SBM and WinS implementation and the effect of technical assistance provided, all schools are enjoined to conduct the Endline Survey on WinS implementation using the Enhanced Three Star Approach Assessment Tool, Likewise, self-assessment on the SBM Level of Practice including DOD must be conducted by all schools using the SBM E-Tool. At least 25% of schools must be validated by the Division TWG, both the SBM Level of Practice and the WinS Star Level of schools.
- 2. Assessment for both SBM and WinS must be conducted by Technical Working Groups (TWG) composed of internal and external stakeholders. Information Technology Officers are directed to provide technical assistance to schools on the processes required to come up with the desired outputs. Schools District Supervisors, School Heads and Health Personnel must coordinate with the Division SBM Coordinator to facilitate the conduct of the activities.
- 3. Excel Form of WinS Endline Survey must be submitted to Schools Division Office for consolidation on or before June 30, 2018, schools are advised NOT to submit online (OMS) the endline survey results. Deadline for validation of results and submission of consolidated division report to FTAD Office is on or before July 30, 2018.
- 4. DepEd Order 83, s. 2012 Assessment Process and Tool (APAT) will still be the basis in determining the SBM Level of Practice utilizing the latest available data in any of the required criteria. Accomplished E-Tool for SBM level of Practice containing all the 60% and 40% shall be submitted to SDO for consolidation on or before July 2, 2018. Consolidated reports must reach FTAD Office not later than August 17, 2018.
