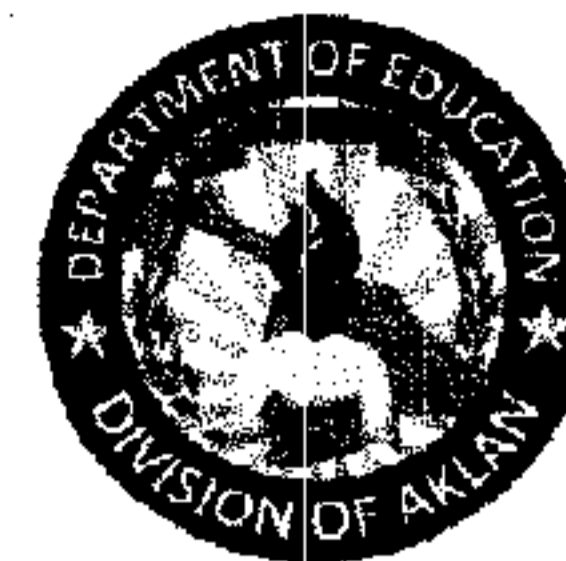

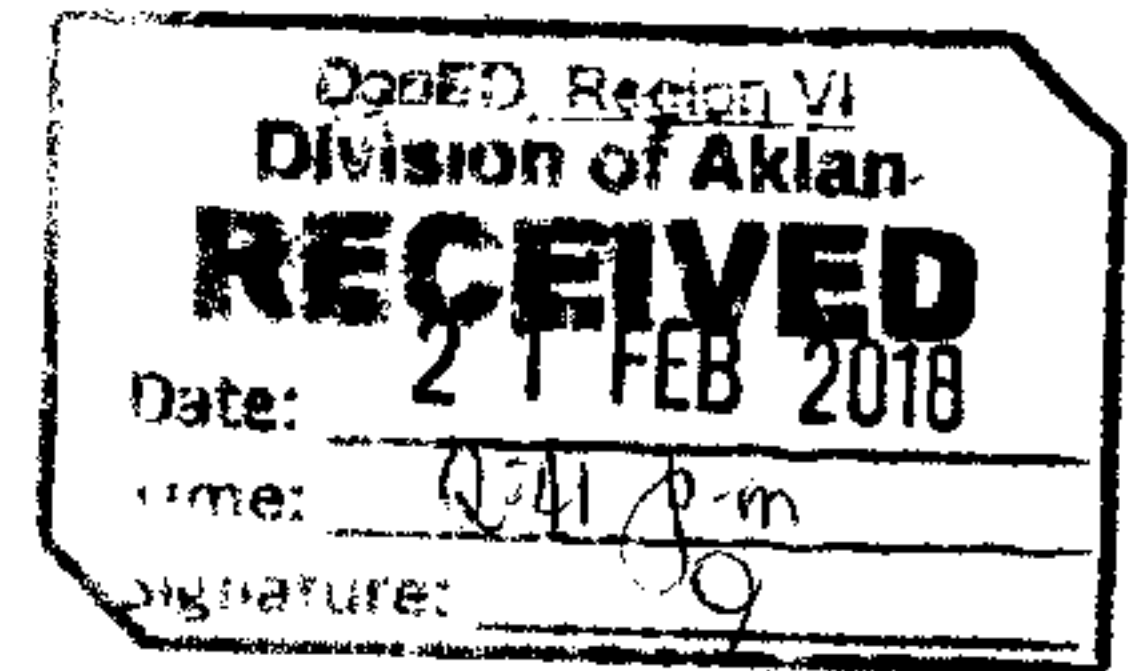

In line with this, I am requesting the support of the Department of Education by sending participants and audience to the contests and the fair. Attached are the mechanics and registration form which may be reproduced.

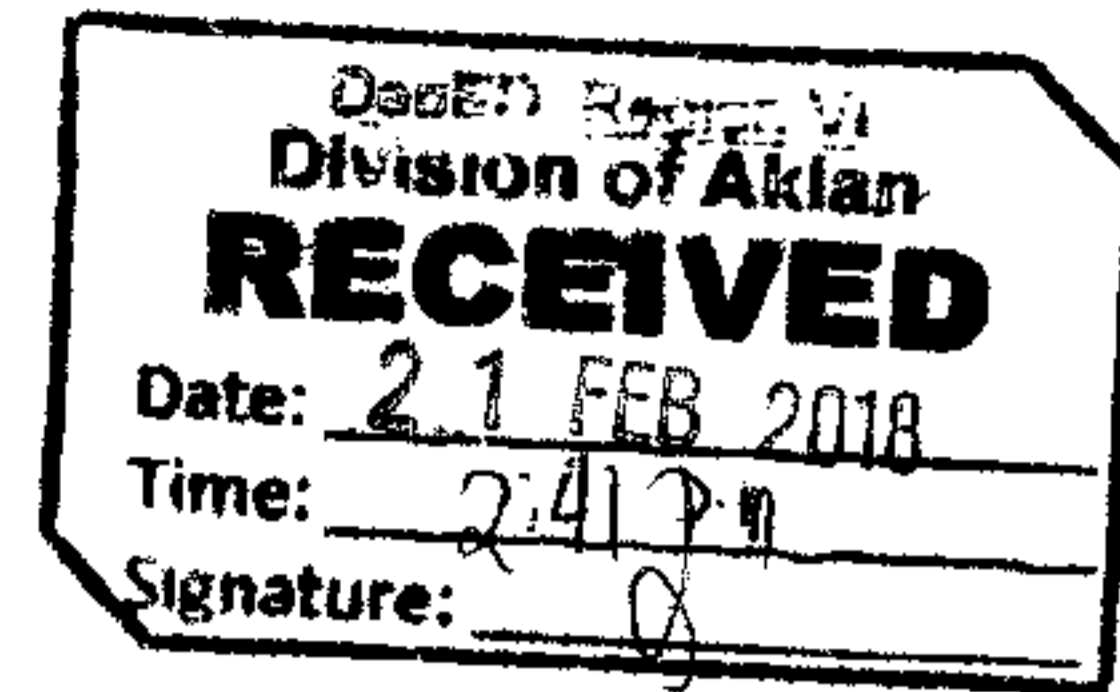
Thank you very much and may we have you as our partner in promoting art appreciation in Aklan.

COMPETITION MECHANICS

Cash Prize

- First Place – P5,000.00 plus gift certificate
- Second Place – P3,000.00 plus gift certificate
- Third Place – P2,000.00 plus gift certificate

Eligibility Requirements

- The contest is open to all Aklanons, 13 years old and above. Each participant must present his/her ID and Community Tax Certificate or Cedula upon registration.
- Contestants must register on or before February 26, 2018 at Kalibo Tourism Office, 2F Kalibo Municipal Hall.
- Each registrant must submit a copy of his/her artwork and will undergo a screening process. There is no registration fee but each contestant shall provide his/her painting materials (paints, brush, etc.).
- All contestants will receive a certificate of participation.

Theme

- The theme of the contest is Vibrant Kalibo. The artwork must be inspirational, informative, and positive.

Evaluation Criteria

- Each contestant is allotted 8 hours to finish a 1m x 2m street/wall art starting at 6:00 AM until 3:00 PM on February 28, 2018. The Board of Judges will appraise the contestants based on the criteria starting at 3:00 PM on the said day.
- Artworks containing discriminatory content, gang names or insignia will be disqualified.
- Any artwork that depicts copyrighted images will also be disqualified.
- The Judges' decision is final and irrevocable.

Terms and Qualifications

- By participating in the contest, you automatically grant LGU - Kalibo non-exclusive, royalty-free, irrevocable license to publicly promote your work of art.
- By participating, you agree to release, discharge, and hold harmless LGU - Kalibo from any and all liability, loss, damage, or injury resulting from participation in this contest.

Creativity and originality	30%
Quality of artistic composition and overall design	30%
Overall impression of the art	10%

TOURNAMENT MECHANICS

Cash Prize

- First Place – P3,000.00
- Second Place – P2,000.00
- Third Place – P1,000.00

Eligibility Requirements

- The contest is open to all Aklanons, 14 years old and above. Each participant must present his/her ID and Community Tax Certificate or Cedula upon registration. There is no registration fee but contestants are required to register on or before February 22, 2018 at Kalibo Tourism Office, 2F Kalibo Municipal Hall. Registration form is available at Kalibo Tourism Office or may be downloaded from the *Vibrant Kalibo Fan Page*.
- Each contestant must submit a copy of his/her piece. Only minimal changes in words may be made after submission. Use of foul words is discouraged.
- The piece may be in Aklanon, Filipino and/or English, free-verse or rhyme poem, and may be delivered through reading or memorization.
- All contestants will receive a certificate of participation.

Evaluation Criteria

- Each contestant is allotted a minimum of 3 minutes and a maximum of 8 minutes for the delivery of his/her piece starting from the first word. 1 point will be deducted from the total score of the contestant for every 15 minutes excess time.
- The elimination round will be conducted on February 23, 24 and March 2, 2018 at Kalye Kulinarya sa Kalibo, Veterans Avenue, Kalibo, Aklan from 6:00 PM to 9:00 PM. The 3 contestants with the highest score will be announced after every elimination and will be qualified for the finals which will be on March 3, 2018, 6:00 PM to 9:00 PM at Kalye Kulinarya sa Kalibo.
- The Board of Judges will appraise the contestants based on the criteria. The Judges' decision is final and irrevocable.

Terms and Qualifications

- By participating in the contest, you automatically grant LGU - Kalibo non-exclusive, royalty-free, irrevocable license to publicly share your piece.
- By participating, you agree to release, discharge, and hold harmless AKTOA from any and all liability, loss, damage, or injury resulting from participation in this contest.

Delivery (Voice clarity, pronunciation and diction) *Memorization will be given weight during the finals	30%
Stage Presence (Attitude, appearance, entertainment factor and showmanship on stage)	15%
Performance (Confidence, competence, dynamism)	15%
Audience Impact	10%
