**GUIDELINES FOR THE OMBUDSMAN VISAYAS
MASCOT DESIGN CONTEST**

1. Qualification

Only accredited Campus Integrity Crusaders (CIC) Program Partners are qualified to join.

2. Mechanics

- a) One entry per Division of the Department of Education (DepEd) in Region VI
- b) The theme of the Mascot Design shall embody the Values and Culture, Vision and Mission of the Office of the Ombudsman.
- c) A brief description explaining the components of the mascot shall be printed in a long-sized bond paper and pasted at the back of the illustration board. The information of the participant shall also be included; name of artist/s, name of organization, name of school, division and address.
- d) The participant shall declare that the Mascot Design submitted is his/her original work, has not been submitted to any other competition, and does not infringe on any third party's existing copyright. Any complaints that may arise due to similarities, likeness or comparison of the design would be the accountability of the participant as he/she would be responsible to prove its authenticity.¹
- e) The winning entry shall automatically become the intellectual property of the Office of the Ombudsman Visayas. The Office of the Ombudsman then shall have the right to edit the winning entry.
- f) The entry shall be submitted to the Office of the Ombudsman Regional Office VI, Iloilo City on or before 09 March 2018.

3. Design

- g) The entry shall be drawn/sketched in a 2-feet by 3-feet illustration board, colored, using any coloring medium.
- h) The contestants shall submit the front, side and back views of the design, each view in a 2-ft x 3-ft. illustration board.
- i) There is no restriction on the number of colors for the Mascot Design.
- j) The design shall see to it that a **mascot costume can be produced**.
- k) The contestant shall give the mascot a name. The height and size of the body parts will also be indicated, in mind that an average human being can possibly fit in and carry it around while walking, dancing and entertaining the crowd.
- l) The design shall illustrate the theme and represent the values and culture of the Office of the Ombudsman. It shall also draw people's attention and acceptability.

4. Criteria

• Relevance to the theme, values and culture of OMB	-	30%
• Originality	-	20%
• Creativity and Workability	-	20%
• Visual Impact	-	20%
• Audience Acceptance/Impact	-	10%
TOTAL	-	100%

5. Prizes. Only one winner shall be selected. There will be a second and a third placer.

The winner will be given a Cash Prize and a Certificate of Recognition.

6. Announcement and Awarding of Winners

The announcement of winners and awarding of prizes shall be conducted during the 3rd CIC Congress (schedule to be announced).
