**OPENING OF CLASSES FOR PRIVATE SCHOOLS  
AND NON-DEPED PUBLIC SCHOOLS FOR SY 2021-2022**

1. Relative to the attached Advisory from the Office of the Secretary on School Opening for SY 2021-2022 dated June 23, 2021, private schools and non-DepEd public schools may already start their classes for SY 2021-2022.
2. The distance learning modalities shall be implemented as no face-to-face classes shall be allowed.
3. To ensure that the said private and non-DepEd schools undertake adequate preparations for the opening of classes, the submission of the following is required: (Refer to D.O.17 s. 2020)
  - a. Letter of Intent (LOI) specifying the date of the opening of classes;
  - b. School Calendar for SY 2021-2022;
  - c. School Plan for compliance with minimum health standards issued by DepEd, consistent with the guidelines of the Department of Health, Inter-Agency Task Force for the Management of Emerging Infectious Diseases, and the Office of the President; and
  - d. School Learning Continuity Plan showing the alternative delivery modalities to be offered until such time that the face-to-face learning is allowed.

**ADVISORY TO PRIVATE SCHOOLS AND NON-DEPED PUBLIC SCHOOLS  
ON SCHOOL OPENING FOR SY 2021-2022**

The Department of Education (DepEd) announces that pending the approval of the new general school opening and school calendar, private schools and non-DepEd public schools may already start their classes for SY 2021-2022, provided that there are no face-to-face classes, and that the school will be strictly implementing only distance learning modalities.

Private schools and non-DepEd public schools intending to start classes ahead of the general school opening shall submit the relevant documents to the Regional Director as required under DepEd Order No. 13, s. 2020 and DepEd Order No. 17, s. 2020 on readiness assessment.
