PHYSICAL FITNESS PROGRAM "GREAT FILIPINO WORKOUT"

- 1. Pursuant to the Civil Service Commission (CSC) Memorandum Circular No. 6, s. 1995, all agencies are required to adopt "The Great Filipino Workout."
- 2. The Great Filipino Workout is the physical fitness project in furtherance of the national policy of "Sports-For-all." It is designed to inculcate the importance of a healthy lifestyle and a regimen of regular physical fitness activities as a strategy to reduce the level of risk factor of heart diseases.
- offices and 3. In this connection, all public and private schools, district division office shall:
 - a. Allot a reasonable time for weekly physical fitness exercise, consistent with CSC Memorandum Circular No. 38, s. 1992;
 - b. Include reasonable period of time for physical fitness exercises by all participants in seminars, training courses and similar occasions; and
 - c. Adopt appropriate plans for continuing physical fitness and sports activities for its officials and employees.

- 4. All public and private school heads shall submit an Action Plan for SY 2018-2019 and the District Office should consolidate the schools' report using the attached format. Reports should be submitted to the Division Office on or before May 25, 2018, attention: Mr. Roland F. Democrito, Education Program Specialist II-HRDS/Division GAD/Child Protection Coordinator.
- 5. Immediate dissemination of this Memorandum is strongly desired.
