


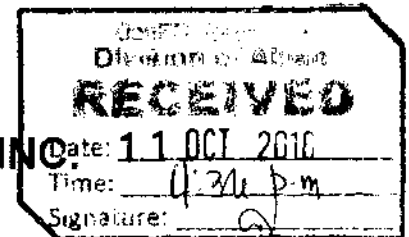

**SUBJ: YOUR APPOINTMENT AS PROVINCIAL & DEPT. OF EDUCATION
COORDINATOR FOR AKLAN PROVINCE**

Congratulations from Philsilat!

After thorough assessment of your application, I hereby appoint you as **Provincial and Dept. of Education Coordinator of Philsilat Sports Association, Inc.**, in Aklan Province.

As Provincial and DepEd Coordinator your main functions are:

- ❖ Shall work directly under the office of the Regional Coordinator and can likewise report if warranted to the National Director for Education, Training and Grassroots Development (NDETGD) and with the Secretary General.
- ❖ Shall be responsible for the propagation of pencak silat, development and discipline of athletes, coaches, trainers, and technical officials under your provincial jurisdiction;
- ❖ Shall be allowed to represent Philsilat Sports Association, Inc., on our behalf to establish linkages and networks within your jurisdiction so that you can request for venues, request support from different government agencies, put-up training gym or conduct pencak silat clinics or gym within your area of jurisdiction, set-up event or competition among grass roots athletes
- ❖ Manages your Local Coordinators (LC) and ensure that they carry-out their duties and responsibilities well.
- ❖ You shall be responsible to Philsilat for all the activities you will be conducting on our behalf and you will submit yourself to audit of activities you or your group shall be conducting on our behalf if warranted.
- ❖ Must oversee the annual planning and its implementation of projects submitted by your Local Coordinators




- ❖ Submits quarterly Reports to the Regional Coordinator, Office of the NDETGD and Secretary General on the projects and updates of his territory.
- ❖ Make sure policies of the NSA , rules and Regulations, Projects are implemented and cascaded down to your LCs or jurisdiction.
- ❖ Shall act as Philsilat and the Regional Coordinators' conduit with the local offices , divisions and districts of the Department of Educations in Iloilo Province on programs and activities the department will have that would need the participation of Philsilat such as but not limited to: local meets, division meets, district meets, provincial meet , regional meets, and with the Palarong Pambansa .
- ❖ **ALL** Activities of your jurisdiction such as but not limited to Competitions, Trainings , Belting, Licensing shall have the approval first of the NSA before proceeding with those activities. Violation of this Section might cause revocation of your appointment.
- ❖ Remuneration for Provincial Coordinator is not part of this mandate, however, Philsilat will try its best to come up with the appropriate remuneration scheme based on the income to be generated by your jurisdiction.

Please note that, this Appointment Letter is not a License to Coach/Train, nor to become a Technical Official (Wasit/Jury) or gives your Training Center/Gym Accreditation. If you wish to become a License Coach/Trainer, Technical Official (Wasit/Jury) or training center/gym become Accredited, please apply for respective licenses and accreditation with the NSA.

Your Appointment is valid until December 31, 2018 and is subject for renewal for one (1) year from January to December of the proceeding year , subject to assessment of your performance. Application for Renewal should not be later than January 17 of every year. This letter of appointment maybe revoked anytime by writing for valid reasons, or until otherwise revoked by Philsilat.
