Please be informed that a software glitch occurred during the preparation of the January 2021 payroll. This affected the deductions intended to pay the employees' loan to Government Financial Institutions (GFIs) and Private Lending Institutions (PLIs). The deductions for GFIs and PLIs were not deducted even though there is still enough net take home pay.

In view of the foregoing, all personnel whose payroll were affected by this error are advised to settle their obligations and pay over the counter (OTC) with the respective GFls/PLIs whose deductions were displaced. It is reminded that failure to pay for the month of January 2021 will cause the GFls/PLIs to impose penalties.
