
REGIONAL TRAINING ON CAMPUS JOURNALISM

To: **Schools Division Superintendents**

1. The Department of Education (DepEd) Regional Office Vi, through the Curriculum and Learning Management Division (CLMD) will conduct the **Regional Training on Campus Journalism** on August 21-24, 2018 at The Grand Tower Suites, Iznart St., Iloilo City.
2. The training-workshop aims to enhance the journalistic, scriptwriting, broadcasting, and online publication skills of school paper advisers and/or journalism teachers.
3. The participants to this activity are the selected school paper advisers and/or journalism teachers of implementers of the Special Program in Journalism who shall be identified by the Schools Division In-Charge of Campus Journalism. The Allotment of Participants Per Schools Division found in Enclosure No. 1 to this memorandum.
4. The participants are encouraged to bring laptop, extension cord and internet connectivity device which are needed during the workshop sessions. The first meal will be dinner on August 21, 2018 while the last meal will be PM snacks on August 24, 2018. The Training Matrix is found in Enclosure No. 2 to this memorandum.
5. Participation to this activity is subject to the no-disruption-of-classes policy as stipulated in DepED Order No. 9, s. 2005 entitled "Instituting Measures to Increase Engaged Time-on-Task and ensuring Compliance Therewith". The school heads should take necessary measure to ensure that the teaching load of the teacher-participants will be taken cared-off and NO classes will be missed by the learners.
6. Since part of the activity fall on holidays, the teacher-participants are entitled to Service Credits where they apply in accordance with DepEd Order No. 53, s. 2003 entitled: "Updated Guidelines on the Grant of Vacation Service Credits to Teachers". On the other hand, non-teaching personnel including the management staff shall be provided with Compensatory Time Off (CTO) as per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
7. The board and lodging of participants shall be charged against OSEC Downloaded Funds for the purpose while travel, per diem and other incidental expenses of the participants shall be

charged to the School Maintaining and Other Operating Expenses (MOOE) Fund/local/SEF or the School Campus Journalism Fund, subject to the usual accounting and auditing rules and regulations. .

8. Immediate and wide dissemination of this Memorandum is desired.
