 - This is to inform the field that there will be a one-day Senior High School First Expo and Job Fair 2018 on March 23, 2018, 8:00 A.M. to 3:00 P.M. at Kalibo Pastrana Park Covered Court, Kalibo, Aklan.
 - 2. The objectives of this activity are to:
 - a. celebrate the initial outputs and gains of SHS learners;
 - b. showcase the skills and abilities of SHS learners;
 - c. build up the awareness of the SHS program among stakeholders;
 - d. strengthen stakeholders' support for the SHS program; and
 - e. offer opportunity for learners to have jobs after they finish SHS.
 - 3. The participants to this activity are:
 - Senior High School Grade 12 students, teachers and school heads from public and private schools including TVIs, HEIs, SUCs, and LUCs which offer SHS;
 - b. LGU officials of the province, municipalities and barangays;
 - c. SHS Work Immersion Program partners and stakeholders;
 - d. Representatives of national, provincial, and local agencies; and
 - e. Other interested community members.
 - 4. Each municipality shall put up a display booth for their SHS products, outputs and services.
 - 5. Senior High School heads are encouraged to invite their SHS Work Immersion industry partners.
 - 6. The Working Committees and other specific details as to the conduct of this one-day activity shall be given in a separate memorandum.
 - 7. The registration fee, travel and other expenses relative to this activity shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
