1. DepEd-Aklan fully supports the continuing professional development of its teaching personnel based on the principle of lifelong learning and DepEd's commitment to the development of teacher potential aimed towards their success in profession.  - a. improve the teaching-learning process that will lead to improved learning among the students;
 - b. nurture successful teachers;
 - c. enable teachers to support each other to continuously improve their content and pedagogical knowledge, practice, skills, and attitudes; and
 - d. foster a professional collaborative spirit among school heads, teachers, and the community as a whole.
3. In line with this, School Heads are advised to submit the School LAC Plan for SY 2019-2020 following the prescribed attached template. District Offices shall compile the school's LAC Plan in one (1) folder and submit to the Division Office attention: Mr. Roland F. Democrito, Education Program Specialist II-HRDS on or before July 26, 2019.
