SUBMISSION OF REPORTS FOR INVENTORY OF SCHOOL SITES AND OTHER REAL PROPERTIES OF DEPED COVERED BY PRESIDENTIAL PROCLAMATIONS AND OTHER EXECUTIVE ISSUANCES

To: OIC, Office of the Assistant Schools Division Superintendent Chief Education Supervisors Education Program Supervisors Public Schools District Supervisors Heads, Public Elementary, Secondary and Integrated Schools All Others Concerned

- 1. The enclosed OUA MEMO 00-520-0022 dated May 13, 2020 issued by Undersecretary for Administration Alain Del B. Pascua calls for the submission of the list of schools for the Inventory of School Sites and DepED Real Properties covered by Presidential Proclamation.
- 2. The inventory shall be submitted by the Office of Undersecretary Pascua and the Office of the Solicitor General to the Office of the President for possible segregation and Omnibus Proclamation in favor of DepED.
- 3. In this regard, the Public Schools District Supervisors (PSDS) and District Physical Facilities Coordinator are directed to coordinate with their school heads who shall report whether their respective school sites are covered by proclamations, presidential proclamations, other executive issuances that bestow on DepED or their school either ownership, occupation or possession of certain parcels of land.
- 3. Each District, through their PSDS and District Physical Facilities Coordinator, is directed to accomplish the herein attached form and email the scanned or legibly photographed copies to the Legal Unit at majade.villanueva@deped.gov.ph.
- 4. If the District has no school site covered by proclamations and other executive issuances, the PSDS and District Physical Facilities Coordinator shall still submit the attached form. They shall only indicate the name of the District, their names and signatures and must fill all other fields therein with "Not Applicable' or N/A and submit it also to the Legal Unit at majade.villanueva@deped.gov.ph.

- 5. Soft copies of the attached form will be posted at Aklan Division Office Personnel Workchat (App) Files or you may email and request for the soft copy from the Legal Unit at majade.villanueva@deped.gov.ph. Deadline of submission of this report is on or before June 11, 2020 at 5 o'clock in the afternoon.
- 6. Immediate Dissemination of this memorandum is directed.
