SuperKID Linis Lusog School Caravan in Region VI

To: Schools Division Superintendents

- 1. The Department of Health, in partnership with Redscope Communications, Inc. is expanding the SuperKID Linis Lusog School Caravan in Region VI for School-Year 2017-2018. This campaign aims to increase awareness among the school populace on developing the habit of handwashing as a basic health/hygiene practice that can prevent infectious diseases.
- 2. SuperKID Linis Lusog School Caravan for School-Year 2017-2018 is composed of two (2) activities:
 - a. Pilot launching of the Continuing Health Education for Teachers (CHET) among. School Heads and Teachers. CHET is an annual assembly that aims to provide updates and new trends relevant to school health. This year's theme is "Health Comes First" focusing on the importance of handwashing as the single most effective practice to prevent diseases.
 - b. The SuperKID School Caravan Event Proper will be conducted in selected 761 Public Elementary Schools. The activity is approximately 60 minutes which will include the SuperKID Cartoon Video Showing; SuperKID Handwashing Quiz Bee; SuperKID Handwashing Relay; and SuperKID Handwashing Champion Oath Taking, simultaneous with Health 101 for mothers in the same school.
- 3. In view of this, and in line with the celebration of Global Handwashing Day 2017, all Schools Divisions in Panay Area are enjoined to send participants to the pilot launching of the Continuing Health Education for Teachers (CHET) on October 14, 2017 at The Mansion (formerly Sarabia manor Hotel), General Luna Street, Iloilo City.
- 4. Participants to this activity are Regional and Division Officials, SBM-WinS Coordinators, Schools District Supervisors, School Heads and Teachers from Panay Area SDOs itemized as follows:
