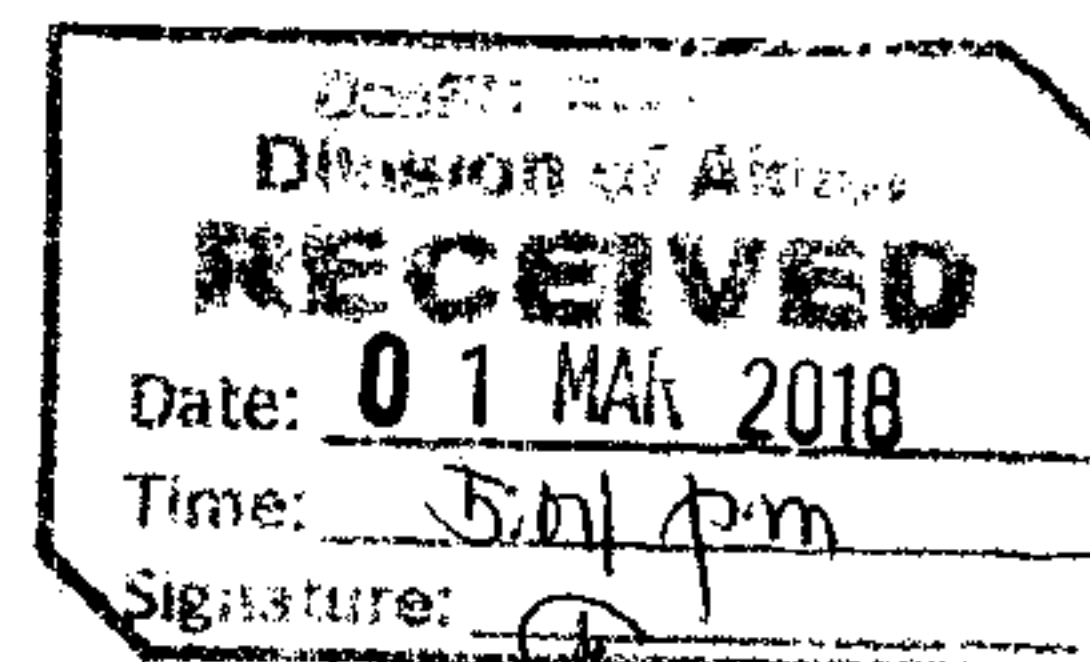

In consonance with DepEd Order No. 55, s. 2013 entitled Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 10627 Otherwise Known as the Anti-Bullying Act of 2013, and Executive Order No. 570 entitled Institutionalizing Peace Education in Basic Education and Teacher Education. The Philippine Taekwondo Association together with Aklan Provincial Sports Office will hold its 2018 Summer Taekwondo Clinic: Training-Workshop on Bullying Prevention Towards Social Emotional Learning from April 16 to May 4, 2018 at RR Taekwondo Training Center, 3<sup>rd</sup> Floor Garcia Building C. Laserna St., Kalibo, Aklan

In addition, Article XIV of the 1987 Constitution, Section 19 which states, "The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry. All educational institutions shall undertake regular sport activities throughout the country in cooperation with athletic clubs and other sectors."

The purpose of this summer training-workshop is to capacitate learners on how to defend themselves against bullies and when to use it. This training has the following objectives:

- Build a network where young people can share experiences and ideas about self-defense;

- Encourage friendship to other learners;
- Enable the participants to develop and/or harness their potentials, self-confidence and discipline; and
- Serve and protect the participants' rights and welfare to become better members of the society.

The target participants are public and private elementary, secondary and integrated schools learners, and all others who are interested in addressing bullying in schools.

Participation of both public and private schools shall be subject to the no-disruption-of-classes policy stipulated in DepEd Order No. 9, s. 2005 entitled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith.
