1. The Public Schools District Supervisor will select one secondary school to participate in the said contest and shall submit an application and endorsement form, and parental consent using the **link bit.ly/YESOIP22 on or before February 28, 2022**.
2. The participant/s to this activity are School YES-O Officers from the selected secondary schools and the contest is to create a proposal and sustain a project that is related to the objectives of this contest.
3. The challenge will start in **March 2022** and participant/s shall post 3-7 minutes of documented video at their **DepEd Tayo – Youth Formation School Page** on **June 1, 2022** with the subject: *YES-O PROJECT INNOVATION*, school, district and hashtags: #depedaklan #depedkabataan2022 #yfd #YES-O #projectinnovation
4. The video must be informative, instructional, and/or entertaining and must not contain any malicious and offensive content.
5. Criteria:
 - a. Methodology (promotion of ecologically friendly practices & approaches) 30%
 - b. Quality and aesthetic impact (presentability of the output) 10%
 - c. Sustainability (period or time frame per harvest and plan of action) 30%
 - d. Social Impact (adaptability to the community) 20%
 - e. Cost efficiency (minimal or no expenses incurred) 10%
6. The following are the modes of verification:
 - a. Methodology - video of the process involved in operation of the project
 - b. Quality and Aesthetic impact – video of the result of the project
 - c. Sustainability – project timeline
 - d. Social Impact – feedback of member/s of the school/community
 - e. Cost efficiency – utilization of recyclable materials
7. There shall be top three (3) winners and shall be awarded of the following prizes:
 - a. 1st Place = Php5,000.00 worth of school supplies
 - b. 2nd Place = Php3,000.00 worth of school supplies
 - c. 3rd Place = Php2,000.00 worth of school supplies
 - d. Special Category: People’s Choice Award = Php1,000.00 worth of school supplies
8. The most number of views will be selected on **June 8, 2022** at 9:00 o’clock in the morning.
9. Other expenses incurred in the operation of the YES-O Project Innovation will be shouldered by the implementers. Linkage with LGUs, government agencies and NGOs for support and sustainability is encouraged.
10. Failure to comply with any requirements set by the guidelines will automatically lead to disqualification.
