Dear **Director Uytico**:

This is relation to the submission of requests for reclassification of teacher positions.

In view of the forthcoming May 9, 2022 National and Local Elections, the Commission on Elections promulgated Resolution No. 10695¹ dated 10 February 2021 pursuant to Batas Pambansa Bilang (BP Blg.) 881², as amended by Republic Act No. 7166³. One of the prohibited activities contained therein is the appointment or hiring of new employees, creation or filling of new positions; promotions or giving of increase in salary or remuneration or privilege for the period covering March 25, 2022 to May 8, 2022 (Section 261 (g), BP Blg. 881).

In addition, our existing internal policy provides that the Notice of Organization Staffing and Compensation Action (NOSCA) issued after the 16th of the current month will be effective the following month unless the date is specified in the memorandum authorizing its effectivity.

Hence, this Office is informing DepEd RO VI that the former would no longer accept requests for reclassification of positions effective 17 March until 8 May 2022.
