DIVISION ORIENTATION AND WORKSHOP ON CULTURAL MAPPING FOR PROJECT PAARAG (First Phase)

1. Historic preservation is an important way for us to transmit our understanding of the past to future generations, specifically Aklanon local and cultural heritage. Thus, this training will help our Philippine History teachers, enhance their skills and competence in writing local history and making a meaningful and relevant support instructional materials.
2. In this light, DepEd- Aklan through the Curriculum Implementation Division (CID) will conduct the **Division Orientation and Workshop on Cultural Mapping for Project PAARAG** (Preserving of Acquired Culture Adhering and Reviving the Past and Accumulating Lessons for the Younger Generations) on **September 29-30, 2022** at **DepEd Old Office, ASJ Hall, Kalibo, Aklan**.
3. The training aims to capacitate division and district Araling Panlipunan Coordinators/representatives and IPED Coordinators in the rudiments of cultural mapping; identify cultural items that promotes preservation and appreciation of both material and non-material culture of the local community and the province; and validate initial data collected and gathered based on legitimate resource materials.
4. Each district will send their **Elementary Araling Panlipunan Coordinator/ representative and IPED** (Indigenous People Education) **Coordinator**.
