#### II. Project Background/Rationale

The DepEd implementation of the Basic Education Program mandated the inclusion of the Senior High School in the ALS Program through DepEd Order 13, series 2019 to provide a better chance for the ALS Junior High School Program passers especially those who are underprivileged to complete their basic education. Moreover, the Republic Act No. 11510 (ALS Act) emphasized that A&E Test passers in Junior High School (JHS) are qualified to enrol in Senior High School program. Thereafter, upon the completion basic education, graduates will also be qualified to enrol in higher education or in technical vocational education and training programs through TESDA. Thus, the successful implementation of the ALS SHS Program will pave the avenue to provide opportunities for the work readiness of the learners and increase their chance of employability.

#### III. Project Objectives

The proposed project aims to:

 provide the ALS Junior High School Program passers a contextualized ALS SHS Curriculum as an option to the existing SHS formal instruction that will cater to the needs of the learners and, 2. provide opportunities to acquire vocational and technical skills for the learners' work readiness and increase their chance of employability.

#### IV. Project Description/Management

The pilot implementation of ALS SHS Program in the Division of Aklan would help and ensure the ALS Junior High School passers complete their basic education and acquire technical competencies and skills needed to enhance work readiness and increase their chance of employability.

The identified Senior High Schools to implement this project are: Altavas National School, Balete Integrated School, Kalibo Integrated Special Education Center and Numancia Integrated School with their function and responsibilities as follows:

#### SCHOOL RESPONSIBILITIES

- Register learners and update their status in the Learner Information System (LIS);
- Receive and allocate the program support fund and implement the activities;
- c. Prepare the planning documents;
- d. Monitor ALS learning interventions progress thru Modular Approach and provide technical assistance to ALS teachers;
- e. Provide a learning space (e.g. classroom) to serve as learning center within a school;
- f. Allow ALS teachers and learners for the use of school laboratories (e.g. Science, LE ITYL, Computer) and other learning resources (e.g. Library, LRMDC);
- g. Monitor various means of enrolment progress of ALS SHS Program;
- h. Record & report of ALS updates/status on a regular basis;
- i. Resource mobilization from stakeholders, using light technologies;
- j. Monitor and supervise the preparation of planning documents/ reports/year-round activities; 1. Forge linkage with stakeholders for additional fund support;
- k. Attend regular meetings on ALS in the DO/RO levels or CO if necessary;
- Provide necessary materials for teachers;

- m. Organize team teaching to allow content specialists in the formal school to teach online/modular approach/face to face for JHS and SHS learning competencies of ALS Curriculum to A&E learners; an
- n. Organize LAC sessions that will also benefit ALS teachers; and
- Coordinate with the school head of the nearest public secondary school for the identification of subject teachers and advisers for the conduct of team teaching

#### ALS SHS COORDINATOR RESPONSIBILITIES

- a. Conduct literacy mapping of potential learners;
- b. Submit class program/program of learning activities to School Head;
- c. Facilitate ALS SHS orientation;
- d. Coordinate with the formal SHS teachers for the team teachers;
- e. Facilitate ALS SHS program interventions;
- f. Guide learners in the preparation and development of portfolio;
- g. Coordinate with the school head for the actual observation of their learning sessions in CLCs;
- Report/coordinate to the school head and submit monthly accomplishment reports; and
- i. Attend comprehensive training program of activities.
