**Creation of the SLR Management Team**

*Within ten (10) days from the issuance of this Order, the Schools Division Superintendent (SDSs) shall create the Division SLR Management Team and shall provide technical assistance in the creation of the School SLR Committee and Division SLR Committee for the Library Hub.*

*The Management Team shall also facilitate the verification process on the priority lists submitted for school libraries or library hubs. It shall verify the parameters used in the identification process.*
