Good Day! This is to formally inform your good office that my wife, **Mrs. ROSELYN T. TAMBONG**, 59 years old and currently the Head Teacher III of Ibao Elementary School in Lezo, Aklan is currently admitted at the Intensive Care Unit of Saint Gabriel Hospital Kalibo for constant monitoring of her condition.

She was admitted last November 9, 2023 wherein she had a recurrent Urinary Tract Infection (UTI) that lead to Sepsis (Sepsis can occur as a complication of a urinary tract infection (UTI), caused by bacteria entering the urinary tract and causing an infection. If the bacteria from the UTI enters the bloodstream, it can lead to sepsis.).

The infection affected her heart that caused mild heart damage as seen in her 2D-Echo resulting for having the symptoms of constant low blood pressure and decreasing oxygen level in her body.

Given her medical condition we are humbly asking and trying to raise funds to sustain her medications and expenses, any amount will help sustain for her fast recovery. I and my children would like to extend our endless gratitude to those who are continuously praying and helping us during this battle. Thank You for your time and kind consideration.
