SUBJ : **REVOCATION OF ALL EXISTING LICENSES OF COACHES & TECHNICAL OFFICIALS FROM 2019 AND EARLIER.** PURSUANT TO THE FULL USE, ADOPTION AND LEARNING OF THE NEW RULES OF COMPETITION (VERSION 7, AS OF NOV. 2023) MADE BY OUR INTL. FEDERATION, PERSILAT, ALL PHILSILAT'S DULY LICENSED COACHES AND TECHNICAL OFFICIALS' EXISTING LICENSES ARE HEREBY REVOKED EFFECTIVE JULY 20, 2024 TO PAVE THE WAY TO THE ISSUANCE OF OUR NEW LICENSE AND DIRECTIVES IN COACHING AND OFFICIATING OF PENCAK SILAT COMPETITIONS THAT ARE SANCTIONED/SUPPORTED BY OUR NSA.

This is to inform all of our duly licensed/accredited Coach and Technical Officials who received their respective licenses or accreditation from 2018 and earlier that pursuant to the Mandate of our Intl. Federation, **PERSILAT** on the use of the New Competition Rules (Version 7, as of November 2023), all Coaches' and Technical Officials' Licenses need to be updated, hence all License /Certificates that were issued from 2019 or earlier will now be deemed "canceled or void" effective July 20, 2024.

All Coaches and Technical Officials are hereby mandated to attend the Coaching and Officiating Training Seminar to have their respective Licenses renewed or updated. Everyone is encouraged to attend the Seminar Training on Coaching and Officiating that will be given in the coming months starting **August until November** of this year so that you can have the opportunity to renew your License/Accreditation soonest.

Further, effective this year License/Accreditation will only be good for 3 years and would be subject to evaluation. Furthermore, all TO's licenses can be upgraded in two (2) years time. Hence, we encourage that all Licensed TO have your upgrading every 2 years.

This is for your information and strict compliance.
