SUBJECT : COURSE FOR MANAGERS OF LEARNING

1. With our dire commitment to provide quality training to Adults in Scouting (AIS) in Western Visayas Region, we are informing the field of the conduct of **COURSE FOR MANAGERS OF LEARNING (CML)** to be hosted by **NEGROS OCCIDENTAL COUNCIL, BSP** on **02-07 NOVEMBER 2024** at **BUENOS AIRES MOUNTAIN RESORT, BAGO CITY, NEGROS OCCIDENTAL**.
2. **Course Description:** CML is the first stage in a 2-stage progressive scheme of training trainers; a 6-day course focusing on the role of the trainer as manager of learning, facilitator, instructor and counselor.
3. This training course is **OPEN TO ALL** including those interested participants from other scouting regions. **Qualifications:**
 - a.) Must be a Two-Beads Holder (*with Wood Badge Parchment Certificate*) for at least 24 months.
 - b.) Should be a registered Unit Leader or Leaders of Adults of the BSP.
 - c.) Should be physically, mentally and medically fit.
4. A Registration Fee of **EIGHT THOUSAND FIVE HUNDRED PESOS (P8,500.00)** shall be charged from each participant to defray the cost of meals and snacks, resort accommodation, souvenir, handouts, training supplies/materials, health kit and other related administrative and program expenses by the staff and participants. Registration Fee, travel, and other related expenses may be charged against MOOE/SEF/Local School Funds subject to its availability and in accordance to the prescribed accounting and auditing rules and procedures.

Teacher participants shall be granted a service credits and for non-teaching participants shall be granted compensatory time-off (CTO) for activities that falls on Saturdays and Sundays pursuant to the DepEd Order No. 76, s. 2012.
